The National Board of Accountants and Auditors (NBAA) is an independent regulatory body established by the Auditors and Accountants (Registration) Act No.33 of 1972 as amended by Act No.2 of 1995. NBAA is charged with the responsibility of promoting, developing and regulating the accounting profession in Tanzania. The Law requires the Board among others, to register members in public practice operating in Tanzania including both individuals and auditing firms. Also the Law stipulates categorically that neither individual nor audit firm can practice in Tanzania without been registered by NBAA. Since it is unlawful for an individual or audit firm to practice in Tanzania without been registered by NBAA, the Board will therefore not be responsible for any reporting entity in the Tanzania that shall use audit services of a firm not registered by the Board and if known, legal action will be taken against such reporting entity.

Thus, reporting entities and the general public are hereby informed that the following is the current list of 151 audit firms registered by the Board as at 15th August, 2011.
